CO-PAYMENT AND INSURANCE AGREEMENT

Dear Parent Guardian of

Every child will be provided with a school owned 64GB WiFi iPad (or its equivalent). Please visit the Apple website for more detailed information about the model of your child's device.

Model

- Apple iPad 10th Generation WiFi

Storage

- 64 GB Flash Storage

Connectivity

- Wi-Fi (802.11a/ b/ g/ n/ ac)
- Bluetooth 4.2 technology

Input/Output

- USB-C
- No 3.5mm headphone jack

Warranty

- 1 Year (From the purchase date of the iPad by the school)

Conditions

- **The iPad remains the property of Iramoo PS until the end of the co-payment period.**
- As part of our co-payment agreement parents will be required to contribute:
\$250 the first year **and**
\$150 in the second year **and**
\$100 in the third year
- *At the end of the third year of the agreement, if all payments have been made, the iPad will be yours to keep.*
- In the event of a child leaving Iramoo before the end of the 3 year co-payment period, families have the option of either:
 - Paying \$500 in full to 'buy out' the iPad
 - OR**
 - Returning the iPad to school in full working order **with any iCloud account removed** and receiving a pro-rata refund appropriate for the year of contribution.
- Your child will receive a personalised 'Lock Screen' picture for the iPad so that we will be able to tell which iPad belongs to which student. **This Lock Screen picture must not be changed.**
- **The 'Mobile Device Management' Profile must not be deleted from the iPad.**
- There **must** be adequate space maintained on each student's iPad so that it can be used effectively for work required at school.
- Every student will receive a **protective case** (value approximately \$55). *The iPad must remain in this protective case.*
- Each iPad will have accidental damage and theft insurance for the period the device is managed by our school. Devices that are released from our Management system are no longer covered (typically when a child leaves at the end of Year 6). The main policy details are included below.

Please note that the excess is \$100 per claim and this must be paid by parents before a new/repaired iPad is returned to a student after a claim has been made.

Main Insurance Policy details:

- Our insurance policy covers theft or accidental damage within Australia.
 - The iPad must be used and maintained according to the manufacturer's recommendations.
 - Theft or malicious damage must be reported to the police and a copy of the police report given to the Iramoo ICT co-ordinator promptly (within 14 days).
- An **Apple ID** must not be entered into the iPad without consulting with our technical staff. The **App Store** will not be made available on the iPad until this step has been completed.
 - Under **no** circumstances is **Jailbreaking** technology allowed on the iPads. The immediate effect is that this **voids** the warranty on the iPad. It also means non-approved and possibly malicious Apps can be downloaded and age restrictions bypassed.
 - No iPad can leave the school until the initial \$250 contribution has been received as this covers the cost of the insurance. Once co-payment for each year has been received, iPads will be able to go home. iPads will not go home in subsequent years until that year's co-payment has been received.
 - No iPad can go home over the December/January Christmas school holiday period unless the full \$500 has been paid.
 - The iPad remains the property of Iramoo Primary School until the end of the co-payment period in the third year.

By signing below, the parent/guardian agrees to the terms of this co-payment and the 3-year insurance policy.

Parent / carer should retain a copy of this agreement for the three-year term of the co-payment and insurance policy.
